Sub.-: Recognition/Approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the assessment report (6th & 7th December, 2017) with regard to Recognition/Approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 3rd April, 2018. The compliance verification assessment report (3rd April, 2018) along with previous assessment report (6th & 7th December, 2017) was considered by the Executive Committee of the Council at its meeting held on 12/04/2018 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (3rd April, 2018) along with previous assessment report (6th & 7th December, 2017) and decided to recommend to the Central Government for recognition/approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 19.04.2018.
