**Sub.-: Recognition/Approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.**

Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the assessment report (6<sup>th</sup> & 7<sup>th</sup> December, 2017) with regard to Recognition/Approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 3<sup>rd</sup> April, 2018. The compliance verification assessment report (3<sup>rd</sup> April, 2018) along with previous assessment report (6<sup>th</sup> & 7<sup>th</sup> December, 2017) was considered by the Executive Committee of the Council at its meeting held on 12/04/2018 and it was decided as under:-

*"The Executive Committee of the Council considered the compliance verification assessment report (3<sup>rd</sup> April, 2018) along with previous assessment report (6<sup>th</sup> & 7<sup>th</sup> December, 2017) and decided to recommend to the Central Government for recognition/approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.*

*The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-*

8 (3) ...

*(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.*

*(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.*

*(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."*

The above decision of the Executive Committee has been approved by the Oversight Committee on 19.04.2018.
