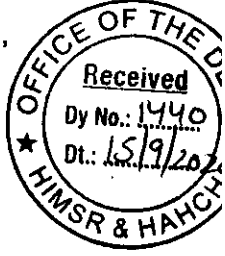

I am directed to state that the Board of Governors considered the Assessment Report (24.06.2020) on the standard of examination and other teaching facilities available at Hamdard Institute of Medical Sciences & Research, New Delhi for purpose of Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 03 seats granted by University of Jamia Hamdard (Hamdard University) and decided as under:-

"The Board of Governors considered the Council Assessor's Report (24.06.2020) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Social & Preventive Medicine / Community Medicine) qualification for 03 seats granted by University of Jamia Hamdard (Hamdard University) in respect of students being trained at Hamdard Institute of Medical Sciences & Research, New Delhi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
