GENERAL TERMS & CONDITIONS

- 1. The tenderer means all parties/firms who respond against this tender notice and successful tenderer(s) mean party/parties, with whom the order is placed and shall be deemed to include the tenderer's successors, representatives, heirs, executors and administrators duly approved by the firm.
- 2. The reputed firm(s) having valid license for dealing with firefighting equipments/fire extinguishers may offer their rate inclusive of all taxes including installation & delivery charges at the delivery point. Intending party are required to furnish the duly certified and authentic documents in support of their workmanship, business experiences etc.
- 3. The tender must be accompanied with the copy of GST registration certificate, which will be verified with the original at the time of opening of tenders. It will be incumbent on the party to provide a certificate issued by the relevant authority to the effect that party is licensed dealer/supplier of the service for which this tender process has been initiated.
- 4. The tender must be accompanied with the copy of Experience Certificate (at least 2 years) which will be verified with the original at the time of opening of tenders.
- 5. The tenderer should submit technical bid and price bid into sealed separate folder.
- 6. The tender completed in all respect should filled on site as given time above Person signing the tender should state in what capacity he/she is signing the tender i.e. Sole proprietor of a firm, the tender must be signed by all the partners Notary form or any other documents forming part of the tender on behalf of another shall produce a proper power of Attorney duly executed in his favour stating that he has authority to bind such other persons in all matters pertaining to the contract. If the person signing subsequently fails to produce the said power of other Civil and Criminal Remedies, cancel the contract and hold the signatory liable for all the costs and damages. The power of Attorney should be signed by all partners in case of partnership concern and in the case of limited companies it should be under the common seal of the company. A copy of memorandum and articles of association should be attached with the tender. Tender and/or amendment submitted after opening the tenders on the schedule date and time will not be considered. Party will also not be allowed to modify the terms and conditions of the tender.
- 7. The installation of refilling/revalidation work is to be completed as per time schedule indicated in supply order.
- 8. The payment will be made through RTGS on submission of original invoice in respected office, the fire extinguishers are properly refilled/installed, tested, and demonstrated.
- 9. Refilling/Revalidation of firefighting equipments /fire extinguishers involves various type of concomitant allied services like painting, HP testing, Anti rust chemical, Container, Siphon tube, gas cartage, Cap, Nosal, Lock, Safety pin, Valve, Washer, Hose pipe etc.
- 10. Number of fire extinguisher may increase or decrease as per the real time requirement.
- 11. Intending parties may inspect the firefighting equipments /fire extinguishers to be refilled/ revalidated on the spot. All the work assigned to the successful party will be carried out on the site itself.
- 12. In the event of failure on the part of successful party to render the assigned work completely or not initiating the assigned work at all or not joining the work after communication of acceptance of his offer. HIMSR shall have the option to get the same work completed from another party at the risk and cost of the appointed party in the first instance.
