As per **MBBS Stray Vacancy Round Counseling Schedule issued by MCC**, HIMSR invites your kind attention to the institutional HIMSR MBBS 2022 STRAY ROUND-1 of counseling to admit vacant seats in **MBBS** programs offered on the basis of **MERIT only**.

The eligible candidates as per list provided by MCC for stray round will only be allowed for registration and participation in the stray round. Counseling for such seats will done on the basis of MERIT ONLY.

The candidates who wish to get admission in **MBBS** through **UG-MBBS STRAY ROUND-1 Counseling-2022 on 27.12.2022**, it has been directed to complete the **Physical Reporting** formalities at Hamdard Institute of Medical Sciences and Research, Jamia Hamdard, Guru Ravidas Marg, Hamdard Nagar New Delhi-110062, **In-Person by the Candidate (Physically Present)**.

The **step-by-step reporting, fee payment & admission process for UG MBBS STRAY ROUND-1** courses are given below. It is instructed that all the candidates should follow the defined process **strictly**.

STEP WISE DIRECTIVES
STEP – 1 Fee payment through <u>DEMAND DRAFT</u> only
Candidate's name/details should appear under NEET Qualified un-allotted (NRI/GEN/MM) Candidate list to be shared by MCC of DGHS.
For NRI/NRI sponsored quota Seat: For OCI, PIO, NRI, NRI sponsored candidates, the prescribed Fee must be paid through DEMAND DRAFT only, and the candidate must produce the original Demand Draft on the day of reporting before registration.
For Muslim Minority/General/Open candidates: The prescribed Fee must be paid through DEMAND DRAFT only. The candidate must produce the original Demand Draft on the day of reporting before registration.
<u>Demand Draft</u> In favor of “ Hamdard Institute of Medical Sciences & Research, Payable at New Delhi ”
<u>NOTE:</u> The prospective candidates shall make all prior arrangements to pay Fee through DEMAND DRAFT only of prescribed Fee mentioned above.

STEP-2 Production of all Original Documents for NRI Seats (Before Registration)
<ol style="list-style-type: none">I. Documents claiming that the sponsor is an NRI (Passport, Visa of the sponsor).II. Relationship Proof of NRI with the candidate (Documents which proves blood relationship should be signed by the Sponsor and Compulsorily Legalized/Notarized) as per the court orders of The Hon'ble Supreme Court of India in case W.P.(c) No. 689/2017- Consortium of Deemed Universities in Karnataka (CODEUNIK) & Ans. Vs Union of India & Ors. Dated 22-08- 2017. https://main.sci.gov.in/supremecourt/2017/23654/23654_2017_Order_22-Aug-2017.pdfIII. Duly notarized Affidavit from the sponsor that he/ she will sponsor the entire course fee of the candidate and the relationship of the sponsor with the candidate is in accordance with the above mentioned court order.IV. Embassy Certificate of the Sponsor (Certificate from the Consulate/Embassy).V. Family Tree notarized by Tehsildar (As per the MCC notification no. Ref. U-11011/05/2022-MEC Dated: 03-11-2022) <p><u>All the above documents (mentioned in I to V of step 2) should be available with the candidate at the time of registration and ONLY ORIGINAL DOCUMENTS will be considered.</u></p>

Other documents to be produced are listed at <https://www.himsr.co.in/wp-content/uploads/2022/11/4.-List-of-Documents-required-at-the-time-of-MBBS-Admission-2022-23-Updated-1.pdf> and same will be verified by the designated Nodal officer.

Registration will be given to only those candidates, who will be Physically Present with Original Demand Draft & Original Documents (As mentioned above).

STEP –3 Registration & Open Merit List

After the successful submission and verification of original demand draft & original documents, an **Open Merit List** will be displayed on college notice board after completion of due verification process of only **Physically Present Candidates** and seat will be allotted strictly according to **Merit only**.

The physical presence of the candidate at the counseling is MANDATORY.

Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.

STEP – 4 Verification & Submission of original documents

Once verification and submission of original documents is completed and if the institution is satisfied with the documents produced and payment of fee made, **merit list will be prepared** and further reporting and admission formalities will be completed.

Discrepancy, if any found the HIMSR will not process their admission & the seat will be offered to the next candidate in the merit list as per merit.

NOTE: The Candidates, who are not able to comply with the above requirements will be deemed to have forfeited their seats and the same will be made available to the next available candidate on the merit basis.

STEP – 5 Reporting of admission at MCC web portal by the HIMSR & Generation of Admission Letter

On successful completion of all steps / process defined above, the admission/reporting details of the selected candidates will be uploaded to MCC web portal by HIMSR Nodal Officer and allotment letter will be generated and admission & reporting formality will be completed.

After generation of admission letter it will be signed by the head of institution, the students are required to take the provisional letter of admission before leaving the campus.
