Stipend for PG trainees: The selected candidates (Non-Clinical), will be paid a stipend of <u>Rs. 80,000 per month</u> for three years duration.

The step-by-step reporting, fee payment & admission process for PG MD/MS SPECIAL STRAY VACANCY ROUND COUNSELING-2022, Non-Clinical courses are given below. It is instructed that all the candidates should follow the defined process <u>strictly.</u>

STEP WISE DIRECTIVES

STEP – 1 Fee payment through <u>DEMAND DRAFT</u> only

Candidate's name/details should appear under NEET Qualified un-allotted Candidate list to be shared by MCC of DGHS.

For ALL CANDIDATES :

The prescribed **Fee must be paid through DEMAND DRAFT only**. The **candidate must produce the original Demand Draft on the day of reporting for registration**.

Demand Draft

In favor of "Hamdard Institute of Medical Sciences And Research, Payable at New Delhi"

<u>NOTE:</u> The prospective candidates shall make all prior arrangements to pay Fee through DEMAND DRAFT only of prescribed Fee mentioned above.

STEP-2 Production of all Original Documents (At the Time of Registration)

The documents to be produced are listed at <u>https://www.himsr.co.in/wp-content/uploads/2022/11/5.-List-of-Documents-required-at-the-time-of-PG-Admission-2022-23-updated.pdf</u> and same will be verified by the designated Nodal officer.

Registration will be given to only those candidates, who will be <u>Physically Present</u> with Original Demand Draft & Original Documents (As mentioned above).

STEP –3 Registration & Open Merit List

After the successful submission and verification of original demand draft & original documents, an **Open Merit List** will be displayed on college notice board after completion of due verification process of only **Physically Present Candidates. The** seats will be allotted strictly according to **Merit only.**

The physical presence of the candidate at the counseling is MANDATORY.

Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.

STEP – 4 Verification & Submission of original documents

Once verification and submission of original documents is completed and if the institution is satisfied with the documents produced and payment of fee made, **merit list will be prepared**, and further reporting and admission formalities will be completed.

Discrepancy, if any found the HIMSR will not process their admission & the seat will be offered to the next candidate in the merit list as per merit.

NOTE:

The Candidates, who are not able to comply with the above requirements will be deemed to have forfeited their seats and the same will be made available to the next available candidate on the merit basis.

STEP – 5 Reporting of admission at MCC web portal by the HIMSR & Generation of Admission Letter

On successful completion of all steps / process defined above, the admission/reporting details of the selected candidates will be uploaded to MCC web portal by HIMSR Nodal Officer and allotment letter will be generated and admission & reporting formality will be completed.

After generation of admission letter it will be signed by the head of institution, the students are required to take the provisional letter of admission before leaving the campus.

Above mentioned vacant seats will be offered strictly on Merit to Candidates.
