

GENERAL TERMS & CONDITIONS

Job Description: Regarding the supply & installation on turnkey basis of Multigrade Filtration and Ultrafiltration system in 400 KLD STP of HAHC Hospital & HIMSR for maintaining the latest parameter of DPCC/CPCB standard.

ELIGIBILITY CRITIERIA

- A. Bidders must be registered for relevant technical work related to wastewater treatment at the government/semi-government. /State Govt./Departments/Hospitals having greater than 500 operating beds. Bidders have to submit the related copies of the documents and other registration certificates, Work orders, and completion certificates. The original will have to be produced when verification is requested.
- B. The Bidders must have current PAN, GST Registration Certificates.

The tender shall be in two bid systems:

- i. Technical Specification: As per Annexure-I and the bidder can also submit supporting documents /catalogue etc.
- ii. Price Bid: As per Annexure-II
- 1. Tender Fee: Rs. 5,000/- In the name of "HIMSR"
- 2. Earnest Money Deposit (EMD): 5% of the quoted value in the name of "HIMSR"
- 3. Validity: 90 days from the date of opening of the tender, offer valid for a shorter period shall be treated as unresponsive & rejected.
- 4. The supply and installation of Multigrade Filtration and Ultrafiltration System should be on a turnkey basis.
- 5. F.O.R.: HAH Centenary Hospital, HIMSR, Hamdard Nagar, New Delhi-110062, Door Delivery duly unloading.
- 6. Turnkey project completion Time: Within 90 days from the date of issue of Work Order.
- 7. Warranty should be applicable for 3 years from the date of satisfactory SITC.
- 8. All Sections & pages of the tender documents strictly should be signed, name and sealed by bidder firm.



- 9. Tenderers/Bidders are advised to inspect the current 400 KLD STP of HAHC Hospital & HIMSR before quoting the rates and understanding the work scope from the concerned Engineer- Incharge.
- 10. The SITC of the Multigrade Filtration and Ultrafiltration System for 400 KLD STP of HAHC Hospital & HIMSR should be done as per the guidelines of DPCC/CPCB, and the latest standard parameters should be strictly followed & also give reference of the DPCC regulation, specification etc.
- 11. The agency shall also be responsible for providing the test reports of standard parameters after the SITC of the Multigrade Filtration and Ultrafiltration System from the DPCC/CPCB Authorized lab.
- 12. If any modification/ defect is found during the inspection by the DPCC/CPCB authorities, the agency shall be solely responsible for resolving the issue & executing the modification work.
- 13. Details of similar works executed in multi-specialty large hospitals. Please attach minimum of two compilations certificates of 80% of the estimated/quoted amount during the last two financial years.
- 14. The bidders shall provide all test certificates & warranty cards related to the Multigrade Filtration and Ultrafiltration System in 400 KLD STP.
- 15. The successful firm shall have to undertake the job after on turnkey basis under supervision of civil engineer department of HIMSR.
- 16. HIMSR reserves the right to reject any or all tenders without assigning any reason thereof.
- 17. Jurisdiction of Delhi Courts only shall apply for all legal disputes.
